POLICE REPORT.

Sgt. Dixon was pleased to report that a housebreaker was caught in the act hiding in the house. He also reported that travelling criminals have been around Edinburgh University stealing mobile phones.

There has also been thieves using electric bikes in the neighbourhood.

Sgt Dixon also recommended the public having their bikes marked. CD asked if the Police could do bike marking again in Morningside near M&S.

In response to MCC concerns about vehicle speeding, he reported that the Police are doing as much as they can when resources are available.

In response to comments about bogus callers in Greenbank area, he suggested not buying anything from callers and in response to concerns about drinking in Morningside park, Sgt Dixon said the Police will visit when resources permit.

Lastly Sgt Dixon informed the meeting that he is being seconded to the NW part of the city. MCC thanked him for his assistance and hope the Police attendance at our meetings will continue.

MINUTES AND MATTERS ARISING.

Minutes agreed.

No update about the bus trackers at the bus stops. CD to contact Cllr Munro.

No update about the damaged paving particularly at crossing Comiston Rd/Belhaven terrace. CD to contact Cllr Munro.

Kerr Fraser, MHA, reported concerns about the deterioration of the wall with stones from the trinity church. MHA have received some funding but more is required. MHA and MCC are still waiting a decision on the community grant application, however an attendee informed the meeting that he attended the meeting and all Morningside applications have been granted funding.

MCC is not clear on rota for councillors attending our meeting. CD to check.

PLANNING

There was a short discussion on how MCC should progress a local place plan and possibly setting up a separate meeting with other local groups to develop a plan. CD to contact Local groups with a view to developing a group to oversee a local place plan consultation.

TRAVELLING SAFELY.

Braidburn Terrace to close for 5 nights for road works.

TREASURER.

WB reported £1031 in MCC account.

SECRETARY.

CD gave an update on the placemaking bid and other matters. Please see the attached update.

It was agreed that MCC should make a bid for a first phase to be funded by the placemaking funding. This first phase involves retaining the two parking spaces and a small loading bay in front of M&S and Superdrug and improve the pedestrian crossing at both ends using raised tables and extended pavements. To accommodate this the taxi rank could be sited on Morningside Park next to M&S. 3 semi mature trees could be planted with in the space. On the paved area at the side of M&S the proposal would also include a small resting space and a few paving slabs lifted and planted with more bike parking nearby.

CD also drew attention to the advertised TRO/23/26 on proposed electronic visitor permits and amendments to diesel surcharge announced.

AOB.

Paul Bailey gave an update on the activity of the Friends of Braidburn Valley Park. They are working with David Kyles from Parks and have been doing a clean up of the old tram shed and have plans for a new picnic table and possible concrete tennis table.

Anne Ness, from Morningside Traders Association, suggested installing a statue of 'Maisie' in Morningside. This idea was well received by the all the meeting attendees.

Anne Ness also suggested that an Edinburgh Bus tours should include Morningside and the Braids. Also the Annual Scottish Independent Retailers of the year competition is still open!
